

Returning to Hong Kong

HKMLE

Requirements:

- Completed no less than 5 years of full time medical training
 - Include a period of full time internship resident in a hospital (eq: F1 or above)
 - Interrupted medical studies are considered case-by-case basis
- Holds medical qualification approved by council
- Applicant is of good character
 - 2 character references required

Examination Structure: Three Parts

Part I: Professional Knowledge

Exam Content and Style:

- t I: Professional Knowledge
 am Content and Style:
 Two papers, 120 MCQ each, available in both English and Traditional Chinese odom
- Single best answer format
- Based on HKU and CUHK question banks
- Negative marking; 1 mark per correct answer, deduction of 0.25 per wrong answer
- Passing mark set at 50% total, but individual papers no less than 40%
- Official Suggested readings
- Sample questions

Comments from past successful licentiates:

- Aim very high MBBS level, but not as far as MRCP
- Resources:
 - MBBS finals material
 - CUHK/HKU question bank
 - HKMLE prep course run by successful licentiates in HK
 - Question Banks: OnExamination / Pastest / USMLE / GMAT
- Preparation time: varies between individuals
 - Did 6 weeks full time revision, 5 days a week
- Basically impossible to be exempt unless substantial experience of practice in relevant discipline

- Basic Sciences (pre-clinical disciplines, such as Anatomy, Pharmacology and Physiology)
- Medical ethics/Community medicine
- Medicine
- Surgery (& orthopaedics surgery)
- Psychiatry

- **Paediatrics**
- Obstetrics and Gynaecology

Part II: Medical English Proficiency

Exam Content and Style:

- 3 hour written English paper
- 40 marks in total: 4 questions, 10 marks each
- Pass mark at 50% (20/40 marks)
- cong Medical Society arks each Question 1 and 2 each include an article and 10 True/False questions
 - Negative marking: 1 mark deducted per wrong answer
 - No deduction for unanswered questions
- Question 3 and 4 requires writing an English passage/letter in response to a scenario

Comments from past successful licentiates:

- Comprehension, summarising results, writing a clinic letter
- No clinical knowledge required
- Should not pose barrier for UK graduates
- Only graduates who started medical school in 2010 may be exempt

Part III: Clinical Examination (OSCEs)

Exam Content and Style:

- Must pass both Part I and II before applying to sit Part III
- Covers 4 specialties: Medicine, Surgery (& orthopaedics), Paediatrics, Obstetrics & Gynaecology
- Exam can be conducted in English, Cantonese or Putonghua (options are on application form)
 - Examiners will normally speak English throughout but some examiners may choose to speak Cantonese or Putonghua to facilitate communication
 - Patient might not necessarily speak English

- Only has capacity for 72 candidates per round
- After passing doctors are required to undergo 12 month internship under HA
 hospitals to be eligible for full registration with Medical Council, beginning on 1
 January or 1 July unless granted deferral

Comments from past successful licentiates:

- Ask for interpreter even just to be safe
- What they look for:
 - Final MBBS level OSCE skills
 - Good communication and professional manners
 - Running commentary
 - Handwashing (alcohol may be hidden!)
- No set pass rate, pass rate range from 10-40 out of 72
- Partial exemptions are possible but require substantial experience/qualifications
- Surgery (& orthopaedics): 10 stations + 2 rest
 - Venepuncture, hernia, varicose veins, shoulder exam, thyroid, handwashing, X-ray/CT interpretation
- Medicine: 1 long case (1 hour), 4 x short case(8 min) + 4 x mini stations (4 mins)
 - 1 hour: full history + Viva questions from examiner(s)
 - 30 min history, 10 min examination, 20 min present findings/Viva
 - Only mention what you want to talk about!
 - o 8 minute: cardio, resp, neuro, abdo, thyroid, breast
 - 4 minute: lab test or imaging interpretation
- Paediatrics: previously hardest (obscure syndromes) but lately OSCE based (easier)
- O&G: station/paper based, MBBS finals standard stations, 10 stations + 1 rest
 - Gynae History, breast exam, PV, speculum, STD testing/counselling

Timeline:

Examinations are now scheduled twice a year.

The examinations happen across two rounds/cycles a year, every March to May and September to December, usually referred to as 1st and 2nd sittings respectively.

Official Exam Statistics

Official statistics no longer includes pass rates by countries, however we have attached Medical Soc screenshots of (2004-2006 rates) at the end of this document.

Resits

Part I: A pass in Part I can be retained for 5 attempts in Part III for 5 years, otherwise, Part I has to be taken again before attempting Part III again.

Part II: A pass in Part II can be retained for 5 attempts in Part III for 5 years, otherwise, Part II has to be taken again before attempting Part III again.

Part III: Having passed 3 subjects in Part III, those passes can be retained for 1 further attempt. If 4th subject is passed at the further attempt then Part III is passed. If not, all 4 subjects have to be taken again.

Failing any part 5 times consecutively prohibits any further attempts at HKMLE unless there is exceptional circumstances justifying 6th attempt.

Internship

Enter a 12 month internship at an HA approved hospital beginning on 01 July or 01 January after passing HKMLE unless deferral has been granted. Upon satisfactory completion of internship, candidate becomes eligible for full registration with the Medical Council.

Applicant is typically expected to begin period of internship in the upcoming July/Jan dates

- Passing at June sitting of the 2019, candidate is expected to begin internship on either 01 July 2019 or 01 Jan 2020
- Passing at December sitting of the 2019, candidate is expected to begin internship on either 01 Jan 2020 or 01 July 2020

Exemptions

Exemption from a specialty of internship training

- Application for exemptions must be made prior to beginning of the internship
- Eligibility:
 - Holds specialist qualification equivalent to Fellowship of Hong Kong College of Physicians
 - Candidate will only take 6 months of internship training in surgical disciplines
 - Holds specialist qualification equivalent to Fellowship of the College of Surgeons of Hong Kong
 - Candidate will only take 6 months of internship training in medical disciplines
 - Holds specialist qualification equivalent to Fellowship of other Colleges under HKAM (except Dental Surgeons)
 - Candidate will only take 3 months internship training **each** (for both medical and surgical disciplines)

Deferral

- Deferral is generally only granted under special circumstances:
 - o Engagement in active clinical practice/clinical training
 - Pregnancies
 - Sickness
- Maximum period of deferral is 3 years from the latest date to begin internship
- Once deferred, applicant must undertake internship as instructed, failing to do so requires applicant to pass all 3 parts of the examination again

Reduction in duration in a specialty of internship training

- Can only apply for reduction in 1 specialty of internship throughout the entire duration
- Must have commenced training in that particular specialty
- All reduction criteria below must be met:
 - Passed all 3 parts of HKMLE at first attempt
 - Completed at least 6 weeks of internship in that specialty
 - Supervisor recommendation for reduction
 - Holds a postgraduate medical qualification in that specialty that is recognised by HKAM as an intermediate qualification
 - Practiced for at least 24 months as clinician in that specialty at a local institution recognised by HKAM

Appeal

Appeals must be made within 14 days of being notified of the decision.

Applicant is not allowed to sit or apply for HKMLE until after final conclusion of appeal.

Any applications submitted prior to appeal will be placed on hold until final conclusion. Appeals can be made for/against following sub-committees:

- Credentials
 - Qualification vetting processes and determining eligibility
- Examination
 - Prepare and conduct examination
 - Certify passes and failures
- Internship
 - Posting, supervision and posting of interns
- Exemption
 - Considers exemptions for examination and internship training
- Review
 - Consider appeals against Credentials, Examination and Internship subcommittees

Limited Registration

What is it?

Medical Society General Register of Medical Council allows eligible persons to register as a medical practitioner in Hong Kong with limited registration. This allows the doctor to work in the public sector under a temporary contract for a maximum duration of 3 years (previously only 1 year). By the end of 2017, there are 144 doctors working in Hong Kong under limited registration. Applications for certain positions are accepted all year round.

Employment for limited registration includes Department of Health (DH), Hospital Authority (HA), HKU and CUHK, for teaching, research, or clinical/hospital work.

The posts/positions available is subject to the needs of HA and DH at the time of application. Department of Health vacancies <u>here</u>. These may include:

- Paediatrics, internal medicine, O&G
- Community medicine, public health, family medicine, occupational and environmental medicine
- Pathology, forensic pathology, anatomical pathology, chemical pathology, clinical microbiology and infection, immunology

Eligibility

- Selected for an employment determined and promulgated by Medical Council
- Obtained acceptable overseas qualification
- Has had adequate and relevant full-time post-qualification clinical experience
- Registered with medical authority outside HK
- Of good character

Job requirements:



- Good spoken and written Chinese and English
- Preferably fluent Cantonese
- Must be permanent residents of HKSAR at time of appointment
- Acceptable overseas medical qualification registrable with medical authority outside Hong Kong
